#### The latest news about the KC Royals possibly choosing North Kansas City

I wish I could tell you there is a decision, but the KC Royals have not announced a decision yet.

However, the Missouri legislature and the Governor recently approved legislation to allow Clay County to create a **sports commission**. A sports commission would serve as the dedicated bridge between community resources and the sports industry, leveraging local assets to attract events, visitors, and investment.

As a move to keep both the Royals and the Chiefs in the state of Missouri the state legislature is going to be called back for a special session to, among other things, consider a bill to enable significant financing for construction of a new stadium. This bill was approved in its regular session by state representatives, but the state senate adjourned before voting on this bill.

If the Royals decide to select North Kansas City, it will almost certainly be necessary for Clay County voters to approve a sales tax increase. The size of such a sales tax increase has not been determined yet. But even though residents and employees in North Kansas City would be impacted, much of the total revenue from a sales tax would be paid by visitors to the city.

In news the last week of May it was revealed that an affiliate of the KC Royals purchased the mortgage on the former Sprint campus at 119<sup>th</sup> and Nall in Overland Park, Johnson County, Kansas. In addition to the many office buildings on that property originally built for Sprint there are many acres of vacant land as well as massive parking garages which were built for the offices. This is not a definitive answer about a future KC Royals decision but it certainly diminishes the odds that a Missouri site will be selected.

## Proposition A pullback by Missouri legislature on paid sick time benefits

The Missouri legislature passed a bill in May to amend Proposition A's requirement for accruing and recording for paid sick time benefits. After August 28, employers will no longer be required by law to for a regulated number of hours worked by employees for earned paid sick time.

Under the terms of Proposition A, employers with business receipts greater than \$500,000 a year would have been required to provide at least one hour of paid leave for every 30 hours worked.
