Important discussion items at this meeting were on the topics of:

- Proposed Water & Sewer Rates
- Bike Master Plan
- RFP for Transportation Services

# **Proposed Water & Sewer Rates**

From the information below you can see that water rates are proposed to increase by 15% and sewer rates to increase by 7% for the next fiscal year (2023-24). Commercial users account for 96% of North Kansas City's water consumption. One employer alone – Ingredion with extensive chemical processing – accounts for more than 50% of the total.

## Billed Consumption by Account Class – July 2022 – June 2023



The chart below shows that North Kansas City's are in the middle of neighboring communities, ever after the increases. Kansas City is by far the highest.

A series of annual increases was implemented so that the Gaming Fund is no longer subsidizing the rate of increases in water and sewer rates. The sewer rates are a direct pass-through of what the City of Kansas City charges North Kansas City.



### **Bicycle Master Plan Update**

There continue to be discussions about the amount of use of existing bicycle paths – both now and proposed for the future. Usage along Armour seems minimal so far but there is a strong belief that North Kansas City

needs to be deliberate in offering bicycle connectivity within North Kansas City and with communities on either side.

#### NKC Bike Master Plan – Projects May be Considered for Reprioritization

- 18<sup>th</sup> Ave Streetscape project from Burlington to Iron;
- 32 Ave shared use path from Burlington/N Oak to Howell;
- Iron Street shared use path from Armour to 18<sup>th</sup> Ave;
- Howell Street shared use path North from 32<sup>nd</sup> Ave to Clark Ferguson Dr;
- Howell Street shared use path South from Ferguson Dr to Armour;
- Hospital Campus share use path follow Clay Edwards Dr from Vernon St to Walker Rd;
- Clark Ferguson bike lanes from Howell to Ozark;
- Ozark Street bike boulevard from Clark Ferguson Dr to Armour;
- E 23<sup>rd</sup> Ave bike boulevard from Swift to Howell/Iron to Ozark;
- ARRA Cycle Track extension shared use path from Vernon to Birmingham (might be impacted by MoDOT PEL);
- Birmingham Connector Path from 210 to Chouteau Tfwy (might be impacted by MoDOT PEL);
- Shared lane markings as recommended by the Bike Master Plan.

### **RFP for Transportation Services**

With KCATA North Kansas City's only FLEX option is with the IRIS program. That is a new point-to-point program introduced by KCATA that has not received good reviews so far.

City Council representative Lisa Tull proposed having an RFP for North Kansas City's own point-to-point within North Kansas City like the former FLEX service.

### Two-Hour Parking on both sides of Clay

Apparently a previous oversight 2-hour parking along Clay was only on the ast side. An ordinance was approved to make sure 2-hour parking is on both sides of Clay.

### Short-Term (Residential) Rentals

A clarification of what is a "short-term rental" was offered. STR would not include 30-60-90 day rentals. It would be more like the 1-2 week VRBO arrangement that many have experienced on vacations. It would include individual bedrooms, with common entry to other parts of the house, as well as whole-house rentals. STR would only be residential zoning districts – the lighter orange districts in the map below.

Registration is required by the City.



# **Reduction of 3 a.m. Liquor Licences**

With the closing of Neon Wild on June 30 the City has the opportunity to further reduce the number of 3 a.m. liquor licenses. Only 3 others remain: Helen's JAD, Spirts Lounge at American Inn and Chappell's (not used). Approved.
