

Discussion Items

Bicycle Master Plan Update

Although several bicycle-related projects have been proposed and some research and planning has occurred only the Burlington Complete Streets project has MoDOT approval to move forward. And construction for that is discouraged until after the opening of the new Buck O'Neill Bridge in late 2024.

MoDOT considerations are dependent on the final recommendations of the I-29/I-35/US 169 PEL (Planning and Environmental Linkages) study. Among other things that project is likely to recommend widening I-29/I-35 by one lane each way from the Bond Bridge to the I-29/I-35 split.

Staff will continue to work with MoDOT on results from the said PEL study, which would largely impact the City. Meanwhile, staff recommends the City reprioritize projects recommended by the Bike Master Plan. A list of other projects that could be considered are shown below:

- 18th Ave Streetscape project from Burlington to Iron;
- 32 Ave shared use path from Burlington/N Oak to Howell;
- Iron Street shared use path from Armour to 18th Ave;
- Howell Street shared use path North from 32nd Ave to Clark Ferguson Dr;
- Howell Street shared use path South from Ferguson Dr to Armour;
- Hospital Campus share use path follow Clay Edwards Dr from Vernon St to Walker Rd;
- Clark Ferguson bike lanes from Howell to Ozark;
- Ozark Street bike boulevard from Clark Ferguson Dr to Armour:
- E 23rd Ave bike boulevard from Swift to Howell/Iron to Ozark;

The **Consent Agenda** include approvals for spending related to move forward with the Sanitary Sewer Master Plan.

Staff Comments included an overview of an evaluation of the **Business License process**. One of the outcomes will be assistance by the North Kansas City Business Council to communicate to businesses more details about how the business license process works and when payments and related documentation are required. Business licence renewals traditionally have a March 1 deadline. Unless your business has a "professional" certification by the State of Missouri then you need to have an annual business license.

City Council Comments included a request from Anthony Saper for feedback about the revised City Council schedule beginning at 6:00 p.m.
