


General Fund

 - Property Tax Pressure




Parks Fund – WITH SALES TAX

 - Self Fund Capital and Maintenance




Gaming Fund

 - Northgate Dropoff 2032







Further Clarification of Planned Uses of the One North redevelopment area



Transfer two bond agreements from SPS Companies/Exitube to Zekelman Industries

A recent sales agreement has transferred ownership of Exltube, a subsidiary of SPS Companies, to Zekelman Industries, the largest steel pipe business in the U.S. City Council took action to transfer the previous agreements for construction of the new steel tube plant at 10Th Ave and Atlantic.

Future Election on April 4, 2023

Four 2-year City Council seats will be open for election at the April 4, 2023 election. Those positions are currently held by Wes Graves. Jesse Smith, Adam Roberts and Amie Clarke. There are also two 1-year terms to be filled for seats held by Connor Fitzgerald and the seat currently held by Ana Pellumbi who is resigning effective the end of this month. Both of these City Council positions are the result of appointments by the Mayor because of resignations. Filing of candidates can be done between December 6 and December 27.

Sales Tax Increase for North Kansas City Parks

City Council approved moving forward with a ballot issue in April to increase the park tax by 25 cents.

Cooperative Agreement for Transportation Planning Software

City Council approved the modest cost to participate with Liberty, Gladstone, Smithville, Excelsior Springs and Kearney in use of software from Replica Inc.
