

## From City Council meeting . . . to the Business Council

Note: As a reminder, the notes below represent topics that, in my judgement, might be of interest to the business community. It does not include everything that was on the agenda.

### Work Session – 6:00 p.m.

The purpose of this work session was to update the City Council about plans for the downtown streetscape improvement project that was approved by a previous City Council in 2019. The area included is from Buchanan to Fayette and from 18<sup>th</sup> to 21<sup>st</sup>.

Planned improvements include replacement of sidewalk pavers, landscaping, irrigation, street trees and existing lighting, along with other amenities. The existing streetscape elements, including pavers and street trees, are reaching the end of their life expectancies and the existing irrigation lines have required extensive ongoing maintenance to keep them in working order.

Here are photos of examples of various types of problems that reflect the deterioration occurring in the downtown district which would be remedied with this project.



The updated estimated cost of the project is now \$3.7 million and will take about 9 months to complete. It will be done in 8 stages so that there is less concentrated disruption in any one area of downtown. It could begin as early as November of this year. The City plans to have frequent communication with downtown businesses concerning the progress of the project. The first action will be removing trees that have been identified as not healthy enough to be a part of the future streetscape.
