BNCCU currently has an opening for what they define as a Retail Manager / Universal Banker. Some of the key job duties are:

- 1. Function as a head teller in scheduling, ordering cash, balancing, etc.

City of North Kansas City will now be able to move forward with One North

A recent article by Thomas Friestad in the Kansas City Business Journal disclosed some facts about the recent \$1.3 million settlement of <u>a federal lawsuit brought last year</u> by the developer behind the partially built One North project. The city will regain control of remaining lots within the \$217.5 million development, positioning officials to seek new proposals. A high priority for the City has been a grocery store, which the developer, North Kansas City Destination Developers LLC., was unable to deliver.

In April 2024, the City Council voted to terminate its master development agreement. Shortly afterward, the development entity sued in the U.S. District Court for the Western District of Missouri, alleging that North Kansas City had wrongfully terminated the One North agreement.

North Kansas City and the One North developer agreed to settle the lawsuit during a late January mediation session. They subsequently negotiated several versions of a comprehensive settlement agreement, according to city documents. The City Council formally approved settlement terms during a special meeting on April 10, and on April 18 filed a joint request for a court order dismissing the case with prejudice.

Under the approved terms, North Kansas City will pay \$1.3 million to One North's development entity, and the builder will release all financial interests in the project, including its \$5.2 million on escrow with the city, plus current and future incentive revenues. The entity also agreed to surrender development rights in One North's remaining land parcels and convey them back to the city by way of a quit claim deed.

Projects that were completed by the former master developer include the Backyard Apartments, Ora Apartments, Old Chicago, Aloft Hotel, Element Hotel, the Diamond Conference Center, Starbucks, the relocated and new Burger King and the medical office building housing Orthopedic Health of Kansas City and Kansas City Urology Care. Although Meierotto Jewelers is located in One North they were not one of the developer's projects.


Every North Kansas City Business has two City Council representatives
